Restrictions of Hazardous Substances (RoHS)

Policy Statement by Toolout Ltd (T/A Jointing Technologies) in respect of the Restrictions of Hazardous Substances (RoHS)

TERMS OF SUPPLY

We declare that all products and/or components supplied by Jointing Technologies are in compliance with the EU Directive 2011/65/EU (as amended by Commission Delegated Directive (Eu) 2015/863 of 31st March 2015). However, we do not test materials for compliance.

This statement is made based upon the information supplied to Jointing Technologies by its suppliers and is accurate to the best of its knowledge.

Confirmation of compliance status by our suppliers is either because the products do not contain any of the restricted substances outlined in the Directive at concentrations in excess of those permitted, or because removal of the restricted substances is not technically possible and their existence in the products at levels in excess of these concentrations is allowed as one of the particular applications listed in the annex to the RoHS3 Directive.

The RoHS Directive restricts the use of certain hazardous substances in electrical and electronic equipment. RoHS bans the introduction of new electrical and electronic equipment to the EU and UK markets containing higher than agreed levels of such hazardous substances. For reference, the current hazardous substances and their maximum allowed concentrations as defined under RoHS are listed below:

Lead (Pb) and its compounds	< 0.1% (as metal)
Mercury and its compounds	< 0.1% (as metal)
Cadmium (Cd) and its compounds	< 0.01% (as metal)
Hexavalent Chromium compounds	< 0.1% (as metal)
Polybrominated Biphenyl (PBB)	< 0.1%
Polybrominated diphenyl ethers (PBDE)	< 0.1%
Bis(2-ethylhexyl) phthalate (DEHP)	< 0.1%
Butyl benzyl phthalate (BBP)	< 0.1%
Dibutyl phthalate (DBP)	< 0.1%
